The Honourable the Chief Justice Rizine R. Mzikamanda SC

It is with great pleasure that I present the Malawi Judiciary Annual Report for the year 2021. The Report provides an account of the state of the Malawi Judiciary in 2021. On the onset, let me extend my deepest gratitude to my predecessor Honourable Chief Justice Andrew K.C. Nyirenda SC (retired) under whose tutelage most of the activities in 2021 took place. The entire Malawi Judiciary is grateful to the retired Chief Justice for spearheading the achievements made during his tenure and wish him well in his retirement.

In the year under review the Malawi Judiciary made some remarkable achievements towards the attainment of its mandate as enshrined in the Constitution. The achievements made resonate well with Malawi Judiciary Strategic Plan for 2019-2024. The theme for the Strategic Plan is "Serving People Better".

Following the approval by Government of the report of the functional review for the Malawi Judiciary in 2020, the Department of Human Resource Management and Development in 2021 provided the Malawi Judiciary a new Establishment Warrant. The new Establishment Warrant has resulted in an increase in the established positions in the Malawi Judiciary from two thousand eight hundred and two (2, 802) to five thousand eight hundred and thirty (5, 830) positions. The new Establishment Warrant followed a rigorous functional review dating back to 2014. This is a milestone noting that the last functional review for the Malawi Judiciary was conducted in 2003. The new Establishment Warrant has created Office of the Deputy Chief Justice, the Court of Appeal, several Departments and the relocation of Internal Audit Section to the office of the Chief Justice, among other things. It is my strong conviction that operationalization of the Establishment Warrant, an exercise the Judiciary has already embarked on, will significantly improve service delivery.

Again in 2021 a number of training, both short and long term took place. Most of the long-term training is on-going at the time of reporting. The training enhanced knowledge and skills of judicial officers and members of staff so that they can better perform their duties.

With regard to infrastructure it is encouraging to note that a number of infrastructure development initiatives continued in the year under review. Rehabilita

tion of Chitipa District Magistrate Court which had commenced in 2019 was concluded in 2021. Rehabilitation works are on-going at Balaka, Rumphi, Likoma, Bolero and Chipoka Magistrate Courts. It is expected that the on-going rehabilitation works will be completed in the course of 2022. These infrastructure development initiatives will not only provide conducive court environment for staff and court users but will also increase access to justice. The rehabilitation works have largely involved an increase in the number of court rooms from one to two at most of the sites.

The achievements highlighted above were not without challenges. Ranking high among them was the coronavirus (COVID-19) pandemic which led to reduced number of working staff and even actual closure of courts at times; inadequate funding and delayed payments which negatively affected implementation of activities including training; shortage of staff and courts which meant that some courts remained non-functional; and lack of vehicles to conduct court inspections and circuits. I am hopeful that building on the strides made in 2021 most of the challenges highlighted above will be mitigated if not minimized.

Looking ahead to 2022 it is my intention that the new Establishment Warrant for the Malawi Judiciary should fully be implemented; use of technology should be increased; and more training and infrastructure development should take place. Let me therefore take this opportunity to call upon all our stakeholders to coordinate and collaborate with the Malawi Judiciary so

that the aspirations I have just mentioned are attained.

In conclusion, I would like to thank all our stakeholders including Development Partners for the support they rendered to the Malawi Judiciary in 2021. Without their support some of the accomplishments would not be possible. Let me also extend my profound gratitude to the Annual Report Editorial Team which is chaired by Justice John Katsala JA and whose other members were Justice William Msiska, Justice Gladys Gondwe, His Honour Kondwani Banda (the Registrar), His Worship Chisomo Msokera (Acting Chief Resident Magistrate - South), Mrs. Edith Chikagwa (Chief Courts Administrator), Mr. Hytone Kadyamo (Regional Courts Administrator - North) and Mr. Allastone Maluwa (Data Entry Clerk in the Supreme Court of Appeal) for their commitment to ensure that after some break there should be an Annual Report.

It is my belief that the 2021 Annual Report will be a useful resource to the Malawi Judiciary as a tool for self-reflection to us as an institution and accountability to our stakeholders so that together we work towards improvement of service delivery.

# Chapter 1

### MISSION, VISION, VALUES AND STRATEGIC GOALS OF THE JUDICIARY

#### Mission

To interpret, protect and enforce the Constitution and all laws in an independent and impartial manner.

#### Vision

Expeditious and impartial justice for all.

#### **Core Values**

Integrity: Being honest, corrupt-free and morally upright

**Transparency:** Providing necessary access to relevant information by the public and other relevant stakehold-

ers

Accountability: Being responsible for and justifying our actions and decisions

#### COMPOSITION, POWERS AND MANDATE OF THE MALAWI JUDICIARY

The Judiciary is one of the three branches of Government. The two other branches are the Executive and the Legislature, also known as Parliament. The separate status, function and duty of the Malawi Judiciary are expressed in section 9 of the Constitution. Under that section, the Judiciary has the responsibility of interpreting, protecting and enforcing the Constitution and all laws in accordance with the Constitution in an independent and impartial manner with regard only to legally relevant facts and the prescriptions of law.

Chapter IX of the Constitution establishes courts at various levels, their compositions and powers. The Supreme Court of Appeal Act provides for the structure and powers of the Supreme Court of Appeal while the Courts Act provides for the powers and functions of the High Court and subordinate courts. In addition, the Labour Relations Act also provides for the composition, powers and functions of the Industrial Relations Court.

#### The Supreme Court of Appeal

The Supreme Court of Appeal is the superior court of record, established under section 104 of the Constitution. It has such jurisdiction and powers as conferred on it by the Constitution or any other law. It is the highest appellate court and has jurisdiction to hear appeals from the High Court and tribunals as an Act of Parliament may prescribe. As such, no court can be established of superior or concurrent jurisdiction with the Supreme Court of Appeal.

The Justices of the Supreme Court of Appeal comprise the Chief Justice and such number of other Justices not being less than three as may be prescribed by an Act of Parliament. The Chief Justice is appointed by the President and confirmed by the National Assembly by a majority of two thirds of members present and voting. Justices of Appeal are appointed by the President on the recommendation of the Judicial Service Commission. A Judge of the High Court may be appointed by the President on recommendation of the Judicial Service Commission to serve as an Acting Justice of Appeal where, for example, there are less than three serving Justices of Appeal. The enabling legislation, the Supreme Court of Appeal Act, further provides for the jurisdiction and the constitution of the court when dealing with a particular matter.

#### The High Court

The High Court is established under section 108 of the Constitution while the Courts Act provides for its structure and additional powers. Except as otherwise provided by the Constitution, the High Court has unlimited original jurisdiction to hear and determine any civil or criminal proceedings under any law which includes reviewing any



law and any action and decision of the Government for conformity with the Constitution. Apart from the Supreme Court of Appeal, there cannot be established a court of superior or concurrent jurisdiction with the High Court.

Besides the Principal Registry based in Blantyre, the Chief Justice, in exercise of his powers under section 7A of the Courts Act, established three district registries of the High Court. These are Lilongwe District Registry, Mzuzu District Registry and Zomba District Registry. In an effort to enhance access to justice there has also been established five specialized divisions of the High Court. The divisions include, Civil Division, Commercial Division, Criminal Division, Family and Probate Division and Revenue Division.

Judges of the High Court are appointed by the President on the recommendation of the Judicial Service Commission.

#### **Subordinate Courts**

Subordinate courts are established under section 110 of the Constitution and are below the High Court. These courts are: the Industrial Relations Court presided over by the Chairperson or Deputy Chairperson and having original jurisdiction over labour disputes and such other issues relating to employment under the Labour Relations Act; subordinate courts under the Courts Acts and the Child Care, Protection and Justice Act which are presided over by magistrates; and Local Courts with the jurisdiction limited exclusively to civil cases at customary law and such minor common law and statutory offences as prescribed by the Local Courts Act which are presided over by lay persons.

His Lordship Honourable Chief Justice Andrew K.C. Nyirenda, SC Chief Justice of the Republic of Malawi




The Honourable Chief Justice Andrew K. C. Nyirenda, SC was born on 26th December, 1956. He is married and has three sons. He holds a Bachelor of Laws from the University of Malawi (1980) and a Master of Laws from Hull University, England (1985).

The Chief Justice has at all times of his career been in public service. He joined the Ministry of Justice as a State Advocate (1980) and moved to the Legal Aid Department as a Legal Aid Advocate. He was posted back to State Advocate Chambers where he was promoted to the ranks of Principal State Advocate, Chief State Advocate, and later appointed Chief Public Prosecutor (now Director of Public Prosecutions). He was appointed Judge of the High Court in 1994 and later Justice of Appeal in 2008. He became the 9th Chief Justice of the Republic of Malawi on 12th March 2015. He retired from service on 26th December, 2021.

During his career, he also authored and published scholarly and practical articles including a book titled "A Comparative Analysis of the Human Rights Chapter under the Malawi Constitution in an International Perspective."



# His Lordship Honourable Justice Edward B. Twea, SC




The Honourable Justice Edward B. Twea, SC was born on 9th April, 1956. He is married and has four children. He holds a Bachelor of Laws from the University of Malawi (1978) and a Master of Laws from Hull University, England (1991).

He started his career in public service as a State Advocate in the Ministry of Justice in July 1978, before joining the Judiciary as a Senior Resident Magistrate in December, 1980. He rose through the ranks to Principal Resident Magistrate, Chief Resident Magistrate (Class C and B) and Deputy Registrar. He was appointed Registrar of the High Court and Supreme Court of Appeal in June 1994. He was appointed as Judge of the High Court in 1997 and later Justice of Appeal in 2009. He retired on 9th April, 2021 after a service of nearly 42 years.



# His Lordship Honourable Justice Rizine R. Mzikamanda, SC



# His Lordship Honourable Justice Anaclet C. Chipeta, SC



#### His Lordship Honourable Justice Mankhambira C.C. Mkandawire





# His Lordship Honourable Justice Sylvester A. Kalembera





# His Lordship Honourable Justice Kenan T. Manda



# Honourable Lady Justice Dorothy nyaKaunda Kamanga



# Honourable Lady Justice Fiona A. Mwale





#### His Lordship Honourable Justice Lloyd Muhara







## Chapter 5



#### OFFICE OF THE REGISTRAR

The Office of the Registrar of the High Court and Supreme Court of Appeal (the Registrar) is established under section 7 of the Courts Act. Under the Constitution, the power to appoint a Registrar is given to the Chief Justice on the recommendation of the Judicial Service Commission.

The Registrar is the Controlling Officer for the Judiciary and bears the responsibilities as provided for under the Public Finance Management Act and the Public Service Act. The office is responsible for the day to day running of the Judiciary at all levels including handling of complaints and public relations. The Registrar reports directly to the Chief Justice.

The Registrar is accountable to Parliament on all issues related to the usage of financial resources appropriated to the Judiciary and on the delivery of its constitutional mandate.

The office of the Registrar is also responsible for case management in the High Court and Supreme Court of Appeal. This entails registration, allocation of resources and, in consultation with Judges, allocation of dates of hearing of cases. Additionally, the Registrar performs judicial functions.

The Registrar is assisted by the Senior Deputy Registrar, the Deputy Registrar and Assistant Registrars. Under the new Establishment of the Judiciary, the office of the Registrar has been renamed as Chief Registrar, with Deputy Chief Registrars to be placed at the Supreme Court and the yet to be established Court of Appeal. There shall be a Registrar (assisted by Assistant Registrars) responsible for each of the High Court Divisions and Registries.

Following the ever-increasing workload and the establishment of new divisions of the High Court, the office of the Registrar has expanded tremendously since the last publication of the State of the Judiciary Report.

#### SUBORDINATE COURTS

#### INDUSTRIAL RELATIONS COURT

The management of the Industrial Relations Court (IRC) is the responsibility of the Chairperson. In the performance of the administrative functions and duties, the Chairperson acts in accordance with policies of the Judiciary and reports to the Registrar of the High Court and Supreme Court of Appeal. The Chairperson is based at the Principal Registry in Blantyre and is assisted by Deputy Chairpersons and Assistant Registrars positioned in the registries of the Court.

In the period under review, the IRC had three registries. The Principal Registry in Blantyre, Lilongwe Registry and Mzuzu Registry. Under the new Establishment, there are three additional registries which are yet to be operationalized. These are Zomba Registry, Kasungu Registry and Luchenza Registry.

#### **COURTS OF MAGISTRATES**

The courts of magistrates are presided over by professional (trained as lawyers) and lay magistrates. The majority of cases in Malawi are handled by the magistrates.

There are four judicial regions which are headed by Chief Resident Magistrates, namely South, Centre, North and East. Under the new Establishment, there are two additional judicial regions, which are South East (Luchenza) and Central East (Kasungu). Below the Chief Resident Magistrates are the Principal Resident Magistrates, Senior Resident Magistrates, and lay magistrates who are graded as follows: First Grade; Second Grade; and Third Grade Magistrates.

#### **PRECEDENTS**

## Summaries of some of the judgments of the Supreme Court of Appeal and the High Court delivered in 2021

#### JTI Leaf (Malawi) Limited v Kapachika

#### SUPREME COURT OF APPEAL

(Being High Court, Lilongwe District Registry, Civil Appeal No. 37 of 2015; and also, being Matter No. IRC 428 of 2012, Lilongwe Registry)

MZIKAMANDA SC., CHIPETA SC., CHIKOPA SC., JJA

Date of Judgment: 13 APRIL 2021 MSCA Civil Appeal No. 52/2016

#### Facts

The Industrial Relations Court (IRC) made multiple awards in favour of the respondent. These included damages for unfair dismissal, an order for the payment of his severance allowance, and an order for payment to him of three months' salary in lieu of notice. The appellant felt aggrieved with the judgment. As a result, it appealed against the same to the High Court of Malawi at the Lilongwe District Registry. The appeal was based on five grounds, which in amended form, were as follows:

- 1. The lower court erred in law in holding that the appellant did not follow the requisite procedure in dismissing the respondent;
- 2. The lower Court erred in law in holding that the appellant had no valid reasons to dismiss the respondent;
- 3. The lower Court erred in law in holding that the respondent was unfairly dismissed;
- 4. The lower Court erred in law in holding that the respondent is entitled to damages for unfair dismissal, severance pay, 3 months' notice pay and Pension dues; and
- 5. The lower Court's decision was against the weight of the evidence.

The High Court dismissed the appeal on the ground that it failed to meet the requirements of Section 65 of the Labour Relations Act (Cap 54:01) of the Laws of Malawi, in that the appeal did not raise questions of either law or jurisdiction but instead focused on factual and evidential issues.

The appellant further appealed to the Supreme Court of Appeal. The question for determination was whether on a consideration of questions of law in an appeal before the High Court from the IRC, matters of fact have any role to play and, if so, to what extent.

#### **Held** – Dismissing the appeal:

- 1. That as per Section 65 of the Labour Relations Act, decisions of the IRC on the facts are final and binding, and that appeals from that Court are only permitted if they are either on questions of law or on questions of jurisdiction, not otherwise.
- 2. That instances will arise where the determination of a question of fact gives rise to a question of law.
- 3. That a misapplication of the law to found facts does amount to an error of law, and on appeal it can lead to a reversal of a lower court's findings.
- 4. That when a consideration of facts becomes necessary in dealing with an appeal on a question of law, the concerned court ought to bear at the fore of its mind a legitimate purpose for getting into such factual consid-

erations.

- 5. That whenever disputes come to court, labour disputes in the IRC included, they can rarely be about an academic application of the law. Of necessity they arise from live factual situations, whose resolution at first instance depends on a matching of the facts obtaining against the applicable law. Of necessity, therefore, even if an appeal following on such adjudication arises purely from questions of law, it would be idealistic to expect that there will be a one hundred per cent divorce of the legal questions from the facts.
- 6. That appellate courts should not resort to facts for purposes of deciding whether the Tribunal or Court below should have made particular findings of fact, but whether it could have lawfully made such findings. The corollary of this is that on their part too, appellants on questions of law should not try to hoodwink appellate courts into delving into factual situations for purposes of drawing factual conclusions that are different from those that were made by the final and binding decisions of the trial court. Appellants will only be right in their approach if they invite appeal courts to go into a consideration of the facts solely for the noble principle of checking whether such findings could have been lawfully made.
- 7. That after going through all the material the High Court dealt with, and after assessing the manner in which the appellant went about supporting its grounds of appeal in the High Court, the Court was convinced that the appellant was not asking that Court to decide whether the IRC could have legally made the factual findings it made on both the substantive and the procedural aspects of the dismissal/termination herein. Its aim, the rehearing had shown the Court, was that the High Court should make factual findings that were opposed to or in disagreement with the conclusions the IRC had come up with on the facts.
- 8. That the appellant herein indeed failed in its said appeal to the High Court to raise questions of law. Having instead only managed to raise therein questions of fact, which was contrary to what Section 65 demands of appellants in appeals from IRC decisions.

#### Khoviwa v Rep

SUPREME COURT OF APPEAL

(Being High Court, Principal Registry, Criminal Sentence Rehearing Case No. 35 of 2016)

NYIRENDA SC. CJ., TWEA SC., MZIKAMANDA SC., CHIPETA SC., CHIKOPA SC., KAPANDA SC., MWAUNGULU SC., JJA

Date of Judgment: 28 APRIL 2021 MSCA Misc. Criminal Appeal No. 12/2017

#### **Facts**

The appellant had been tried and convicted of murder in the Court below and had been sentenced to the mandatory death penalty that was imposable under Section 210 of the Penal Code. Kafantayeni and Others v Attorney Gener-



al. He appealed to the Supreme Court of Appeal against both conviction and sentence. His appeal was dismissed; both the conviction and the mandatory death penalty were upheld. In the interim, the decision of Kafantayeni and others v Attorney General was rendered. The appellant wanted to benefit from the sentence re-hearings that were done in similar murder and mandatory death penalty cases. He applied to the Court below for a sentence rehearing in the hope that the death penalty that had been imposed on him would be subject to the discretion of the Court. That application was refused and this appeal was against that refusal by the Court below to accord the appellant a sentence rehearing. The grounds of appeal were these:

- 1. The Court below erred in not according the appellant a sentence rehearing since it was duty bound to accord him a sentence rehearing based on the Supreme Court of Appeal Judgment of Maclemonce Yasini and another v Republic MSCA Criminal Appeal No. 25 of 2005 and the Judgment of the High Court sitting as a Constitutional Court in Kafantayeni and others v Attorney General Constitutional Case No. 12 of 2007.
- 2. The Court below erred in equating an appeal on sentence to a sentence rehearing and deciding that the two are alternatives as the two are different legal processes and an appeal cannot be a substitute or alternative for sentence rehearing.
- 3. The Court below erred in not according the appellant a sentence rehearing on the basis that the appellant had earlier appealed to the Supreme Court of Appeal as the decision of the Supreme Court of Appeal on the death sentence was decided per incuriam\_since at the time of entertainment of the appeal on death penalty there was no valid death penalty at all against the appellant the same having been declared unconstitutional and hence void ab initio.
- 4. Not according the appellant a sentence re-hearing is both discriminatory and arbitrary.

**Held** – the majority allowing the appeal on grounds of appeal 1, 2 and 4 and ordering a sentence re-hearing:

- 1. That in matters of sentence re-hearing, the doctrine of res judicata cannot be allowed to hinder the process. The defence of res judicata should never arise when the Court decides to conduct a sentence re-hearing, whether before or after an appeal to this Court confirming the death sentence. The appellant was entitled to a sentence re-hearing before the Court below. The appellant should have been allowed a sentence re-hearing regardless of the result of his appeal to this Court.
- 2. That there remains a clear distinction between an appeal process and a sentence rehearing, in more ways than one. The procedures between the two processes are quite distinct, one from the other. As was submitted for the appellant, the procedures are different. While in sentence re-hearing evidence may be enlisted, in mitigation or otherwise, it is not characteristic for an appeal to involve enlisting of evidence. Sentence re-hearing must remain the responsibility of the trial and sentencing court. An appeal can then go up the Court above the trial or sentencing Court. It was, therefore, correct to submit that an appeal is not a substitute for a sentence re-hearing.
- 3. That Kafantayeni and others v Attorney General only dealt with the issue about the unconstitutionality of the mandatory aspect of the death penalty and not the constitutionality of the death penalty. The latter was not an issue before the Court. It was therefore not accurate to suggest that the death sentence was void ab initio or invalid ab initio at the time the Supreme Court of Appeal determined the first appellant's appeal. The argument that the Court determined the appeal per incuriam was without basis and it was rejected.
- 4. That the mandatory death penalty passed on the appellant based on the defunct section 210 of the Penal Code was tainted with unconstitutionality to the extent that it was mandatory and there was no evidence proffered in mitigation at the time of the sentencing.



#### **Democratic Progressive Party v Attorney General**

# HIGH COURT PRINCIPAL REGISTRY (Being Civil Case No. 230 of 2021) KALEMBERA, MBVUNDULA, KAMANGA, MTALIMANJA, LIGOWE, JJ

Date of Judgment: 26 NOVEMBER 2021 Constitutional Referral No. 3/2011

#### Facts

On 7th June, 2020, the former President, Professor Arthur Peter Mutharika (Professor Mutharika) appointed the Sixth Cohort of the Electoral Commission ("the Commission"). The appointees were Justice Dr. Chifundo Kachale as Chairperson and Mr. Arthur Nanthuru, Dr. Jean Mathanga, Ms. Linda Kunje, Mr. Steve Duwa, Ms. Olivia Liwewe and Dr. Anthony Mukumbwa as members. On 16th June, 2020 the Malawi Congress Party and Dr. Lazarus McCarthy Chakwera (Dr Chakwera) commenced judicial review proceedings, styled Judicial Review Cause No. 34 of 2020, Malawi Congress Party and Dr Lazarus McCarthy Chakwera v The President of the Republic of Malawi at the High Court Lilongwe District Registry, challenging, in the main, the appointment of two of the Commissioners.

On 23rd June, 2020, the Sixth Cohort of the Commission, as appointed on 7th June, 2020, presided over and managed the Fresh Presidential Elections ("FPE 2020"), which returned Dr. Chakwera as President and Dr. Saulos Klaus Chilima as Vice President. This Cohort also presided over and managed diverse by-elections for Members of the National Assembly and Local Government Councils.

On or about 7th April 2021, the President rescinded the appointments of Dr. Jean Mathanga and Ms. Linda Kunje as Commissioners of the Sixth cohort of the Commission. The rescission was withdrawn by the President through his letter dated 28th May, 2021, pursuant to the decision of the High Court, Principal Registry in Civil Cause No. 45 of 2021, Dr. Jean Mathanga and Linda Kunje v Electoral Commission and Attorney General.

On or about 24th June, 2020, the Malawi Congress Party and Dr. Chakwera withdrew and discontinued the judicial review proceedings. On 19th March, 2021, the Malawi Congress Party and Dr. Chakwera applied for and were granted permission to revive the said proceedings. Subsequently, Dr. Chakwera applied for and was granted an order removing himself as a party to the judicial review proceedings and the remaining parties were Malawi Congress Party v The President of the Republic of Malawi. Dr. Jean Mathanga, Ms. Linda Kunje, Mr. Steve Duwa and Mr. Arthur Nanthuru joined the proceedings as Interested Parties.

The judicial review proceedings culminated in a judgment of 2nd June, 2021 in which the Court held that four out of the six Commissioners were not duly appointed as members of the Sixth Cohort of the Commission, as their nomination and appointment were done in breach of section 4 of the Electoral Commission (Amendment) Act, 2017. The Court further held, on the premise of section 42 of the General Interpretation Act, (Cap 1:01), of the Laws of Malawi, and on the authority of the cases of Chilima and another v Mutharika and another, Constitutional Reference No. 1/2019 (unreported) and Mutharika and another v Chilima and another Constitutional Appeal No. 1/2020 (unreported), that the actions and decisions of the Sixth Cohort of the Commission were not affected by



the defect in the appointment of four of its members.

The Court also held that the fact that the case referred to section 75 of the Constitution did not make it, or certain parts thereof, fit for determination by the High Court sitting as a Constitutional Court.

On 8th June, 2021, the Claimant commenced proceedings at the High Court, Principal Registry, ("original Court") in Civil Cause No. 230 of 2021 seeking reliefs as follows:

- 1. A declaration that the rescission of the appointment of the two Commissioners of the Seventh Cohort of the Electoral Commission rendered the Seventh Cohort of the Electoral Commission inquorate and unconstitutional under Section 75 (1) of the Constitution of the Republic of Malawi as from the date of appointment of the Seventh Cohort of the Electoral Commission on or about the 7th June 2020.
- 2. A declaration that the decision of the High Court of Malawi in Malawi Congress Party v The President of Malawi and Four Others, Judicial Review Cause No. 34 of 2020 which declared that four Commissioners of the Seventh Cohort of the Commission were not validly appointed, reduced the Seventh Cohort of the Electoral Commission to only two validly appointed Commissioners and a Chairperson as from the date of the appointment of the Seventh Cohort of the Electoral Commission on 7th June 2020 and therefore the Seventh Cohort of the Electoral Commission was inquorate and unconstitutional from the day of its appointment.
- 3. A declaration that under Section 75 (1) of the Constitution of the Republic of Malawi, any vacancy in the composition of the Electoral Commission appointed with the minimum number of Six Commissioners, renders the Commission inquorate and unconstitutional; and thereby incapable of exercising any powers and functions in relation to elections in Malawi as provided for in Section 76 of the Constitution including presiding over, managing and conducting any elections including the purported Fresh Presidential Elections held on 23rd June 2020 in Malawi and all the By-elections conducted by the said inquorate Electoral Commission.
- 4. A declaration that under Section 75 of the Constitution of the Republic of Malawi, an unconstitutional and inquorate Electoral Commission does not have the Constitutional powers or mandate to preside over, manage and or conduct any elections in the Republic of Malawi.
- 5. A Declaration that Section 42 of the General Interpretation Act (CAP. 1:01) of the Laws of Malawi is inconsistent with the Section 75 (1) of the Constitution, and therefore invalid to the extent of such inconsistency under Section 5 of the Constitution of the Republic of Malawi.
- 6. A declaration that section 10 of the Electoral Commission Act, CAP. 2:03) of the Laws of Malawi in inconsistent with the Section 75 (1) of the Constitution, and therefore invalid to the extent of such inconsistency under Section 5 of the Constitution of the Republic of Malawi.
- 7. A declaration that the Seventh Cohort of the Electoral Commission having been rendered unconstitutional and inquorate, the Fresh Presidential Elections presided over, managed and conducted by the unconstitutional and inquorate Seventh Cohort of the Electoral Commission on 23rd June 2020 and all subsequent Parliamentary and Local Government By-Elections, are thereby null and void ab initio.
- 8. A declaration that the purported election of the President and Vice President on 23rd June 2020 and the subsequently purported swearing into the offices of President and Vice President of the Republic of Malawi are null and void ab initio.
- 9. A declaration that the Members of the National Assembly and Local Government Councils purportedly elected in elections presided over, managed and conducted by the unconstitutional and inquorate Seventh Cohort of the Electoral Commission and subsequently sworn into their respective offices as Members of the National Assembly and Local Government Councils in the Republic of Malawi, are thereby null and void ab initio.
- 10. Consequential orders and directions that the status of the Presidency of the Republic of Malawi revert to the

position it was prior to the appointment of the unconstitutional and inquorate Seventh Cohort of the Electoral Commission.

- 11. Consequential orders and directions that the offices of Members of the National Assembly and Local Government Councils purportedly elected in By-Elections presided over, managed and conducted by the unconstitutional and inquorate Seventh Cohort of the Electoral Commission and subsequently sworn into their respective offices of Members of the National Assembly and Local Government Councils in the Republic of Malawi revert to the positions they were in prior to the holding of such purported By-Elections.
- 12. Consequential orders and directions for the Fresh Appointment of the Seventh Cohort of the Electoral Commission.
- 13. Consequential orders and directions for the holding of Fresh Presidential Elections as directed by the Constitutional Court and the Malawi Supreme Court of Appeal on 3rd February 2020 and 8th May 2020 respectively.
- 14. Consequential orders and directions for the holding of Fresh Parliamentary and Local Government By-Elections in all the Constituencies and Local Government Councils where By-Elections were purportedly held, managed and presided over by the unconstitutional and inquorate Seventh Cohort of the Electoral Commission.
- 15. Any other consequential orders and directions as this Honourable Court shall deem fit and constitutional in the circumstances.

The original court referred the matter to the Chief Justice for certification as a constitutional matter to be presided over by a panel of not less than 3 Judges. Once the Chief Justice certified the matter, the defendant raised preliminary issues. And during the course of the hearing, the claimant in turn raised one additional preliminary objection. From the objections, the court outlined the following issues for determination:

- 1. Whether the Attorney General must take an oath of office in order to have standing in court;
- 2. Whether the High Court has jurisdiction to overturn its own decision or to review its own decision and whether a High Court judgment can constitute a cause of action;
- 3. Whether the present proceeding is aimed at reviewing or appealing against the decision of the High Court on similar issues:
- 4. Whether non-compliance with section 4 of the Civil Procedure (Suits by or against Government or Public Officers) Act is fatal to the proceedings commenced against the Attorney General and whether the present proceedings can be dismissed for failing to comply with section 4 of the Civil Procedure (Suits by or against Government or Public Officers) Act;
- 5. Whether a political party has locus standi to challenge the results of an election and whether the Claimant and the Defendant are proper parties to the present proceeding;
- 6. Whether the Claimant having deliberately contravened the law in recommending the appointment into the Electoral Commission of more than three nominees, should be allowed to benefit from its own illegality and whether it should be estopped from challenging the decisions of the members of the Electoral Commission who were appointed into the Electoral Commission in contravention of section 4 of the Electoral Commission Act;
- 7. Alternatively, whether the present proceeding seeks to benefit the Claimant from its own unlawful and illegal act:
- 8. Whether the present proceedings should have been commenced by way of petition and whether the present proceedings have been wrongly commenced;
- 9. Whether or not the present proceedings are statute barred under section 100 of the Parliamentary and Presi-



- dential Elections Act, having been commenced more than seven days from the declaration of the result of the election; and
- 10. Whether or not, the present proceedings are frivolous, vexatious and an abuse of court process and a waste of the Court's time.

#### **Held** – striking out the action:

- 1. That the framers of the Constitution did not intend for the Attorney General to take an oath of office. The Court finds that the Attorney General was properly before the Court.
- 2. That the certification was made subject to the Referral and that Order 16 rule 6 of the Courts (High Court) (Civil Procedure) Rules allows a court to consider preliminary issues, the Court concluded that the said preliminary issues were rightly before the Court and the Court was within its legal mandate in entertaining them.
- 3. That the issues in the proceedings were the same as those in Malawi Congress Party v The President of the Republic of Malawi which was decided by the High Court, Lilongwe District Registry. Therefore, this was an appeal in disguise and the Court had no jurisdiction to entertain it.
- 4. That the three prerequisite elements establishing res judicata (re-litigation) namely, existence of a final judgment, identity of parties and identity of subject matter obtained in this matter.
- 5. That the concept of functus officio was inapplicable in the case for the reason that it was not this Court which rendered the judgment in Malawi Congress Party v The President of the Republic of Malawi, which was registered as Judicial Review Cause no. 34 of 2020 and heard at the High Court Lilongwe Registry.
- 6. That the proceedings were incompetent because the claimant was relying on the judgment in Malawi Congress Party v The President of the Republic of Malawi as its cause of action. The Court having established that the judgment does not constitute a cause of action.
- 7. That the Court rejected the Defendant's assertion that this was an election matter which should have been commenced by way of petition. The reason was that the three factors that must obtain in an election petition had not been satisfied, in that (i) the complaint did not arise "due to an act or omission during an election," (ii) the Claimant had no right to be elected at an election and (iii) the Claimant was not a candidate at such election.
- 8. That having established that the proceedings did not constitute an election matter the limitation period of seven days under section 100 of the Parliamentary and Presidential Elections Act does not apply.
- 9. That having established that the action was an appeal in disguise and/or a re-litigation of the issues, the finding was that the Claimant lacked standing to approach the Court in the manner it had done by commencing fresh proceedings.
- 10. That there exists no juristic person known as the 'Office of the President of the Republic of Malawi'. Whilst the Attorney General can be sued on account of the actions or omissions of the Government or a public officer, he is not sued in abstract. Since the 'Office of the President of the Republic of Malawi' is not a legal person, the Attorney General had been sued in abstract and was therefore a wrong party.
- 11. That the requirement for the section 4 notice requirement of 3 months could not be dispensed with for the reason that the proceedings were commenced by a summons under Order 5 of the Courts (High Court) (Civil Procedure) Rules.
- 12. That the principle relief sought by the Claimant, namely, nullification of the results of the 2020 presidential elections and the subsequent Parliamentary and Local Government by-elections, if granted, would have the effect of benefiting the Claimant from its own illegality.
- 13. That having found that the proceedings were an appeal in disguise or an attempt to re-litigate the issues in Malawi Congress Party v The President of the Republic of Malawi which were caught by the doctrine of res judicata, the Court concluded that the proceedings were frivolous, vexatious and an abuse of the process of

the court.

- 14. That the issues raised in this matter were dealt with to finality in the case of Malawi Congress Party v The President of the Republic of Malawi. The Claimant accepted both the rescission letter and the judgment in Malawi Congress Party v The President of the Republic of Malawi. This implied that there was no dispute for the Court to determine and that the Claimant merely sought the Court's advisory opinion. The finding was that the matter was not within the jurisdiction and competence of the court.
- 15. That having established that no cause of action had arisen and that the Claimant had not shown that any dispute had been triggered and that the Claimant only sought the Court's advisory opinion, the Court concluded that the matter was moot, hypothetical and academic.



#### COURT SERVICES AND GENERAL ADMINISTRATION

Court administration broadly involves the performance of many functions including human resource management, fiscal or financial management, case flow management, information and technology management, jury management, infrastructural or estate development, public relations, intergovernmental liaison, security, procurement, court reporting, court interpretation and advisory services. In our context, some of the managerial functions overlap with judicial functions. This is also reflected in the Judicature Administration Act, Cap. 3:10 of the Laws of Malawi which vests such responsibility in the offices of the Registrar of the High Court and the Supreme Court of Appeal and the Chief Courts Administrator.

The Chief Courts Administrator is the most senior member of staff of the judiciary. Under the Act, he or she is responsible for overseeing the general administration (including security, procurement, information and technology management, and infrastructure development, financial management and human resource management) of the Judiciary.

According to section 3 of the Act, the Chief Courts Administrator is subordinate to the Registrar but subject to the direction of the Chief Justice in the discharge of his or her duties and functions. The Act also governs the terms and conditions of service for members of staff of the Judiciary who, under the Act, are all non-judicial officers.




#### INFORMATION COMMUNICATION AND TECHNOLOGY DIVISION

#### PROCUREMENT SECTION

This Section is responsible for the acquisition and disposal of goods, services and works in the Judiciary. Some of the procurement is centrally done at the headquarters such as procurement of motor vehicle insurance for judges, judges' regalia, procurement of judges' medical cover, consultancy services, and major court rehabilitation works while the procurement of other goods and services and disposal of those goods is decentralized.

According to the Establishment Warrant, the Section is headed by the Chief Procurement Officer. However, the position is vacant. In the meantime, the duties of that office are being performed by a Procurement Officer.

The major procurements in the year 2021 included procurement of judges' regalia, consultancy to design and supervise construction of Judicial Complex in Lilongwe, rehabilitation of Chipoka and Bolero Magistrate Courts, procurement of furniture for selected magistrate courts, construction of carpark at Chichiri Court premises, security services, health insurance, motor vehicle insurance cover and motor vehicles for the Security Services Section.

#### SECURITY SERVICES SECTION

The Section is responsible for ensuring the safety and security of personnel and premises of the Judiciary. In the operationalization process of the Section, the Judiciary has started the recruitment and training of Troopers who, in the long run, will be responsible for providing security to all the establishments of the Judiciary and premises of judicial officers. #### OFFICE OF THE SHERIFF OF MALAWI

The Office of the Sheriff of Malawi is created under the Sheriffs' Act, Cap. 3:05 of the Laws of Malawi. It has the responsibility of enforcing judgments and orders of all courts. Enforcement is the last stage of the judicial process after the legal rights of the parties have been determined in a judgment or an order.

During this process, a judgment or an order of the court is made effective in order to enable the successful party reap the fruits of his judgment. Conversely, where there is voluntary compliance with the judgment or order of the court by the losing party, enforcement by sheriffs becomes unnecessary.

The Office of the Registrar also serves as the Office of the Sheriff of Malawi. In practice, the day-to-day administration and management of that Office is done by the Office of the Deputy Sheriff which position is vacant. In the meantime, the duties of that Office are being performed by the Principal Assistant Sheriff.

#### **COMMUNITY SERVICE DIRECTORATE**

Community Service is one of the alternatives to custodial sentence under the Criminal Procedure and Evidence Code. In 2005, the Judiciary established a Community Service Directorate, as secretariat to the Malawi National Committee on Community Service established pursuant to Rule 3 of the Community Service (General) Rules made under section 364A of the Criminal Procedure and Evidence Code, Cap. 8:01 of the Laws of Malawi. The primary function of the Directorate is to implement Community Service Orders made by Courts.

It is worth noting that there is re-thinking on the placement of the Directorate. To that extent, the Directorate has since been deleted from the Establishment Warrant of the Judiciary. A decision is yet to be made as to where it will be placed.

#### CHILD JUSTICE SERVICES DIRECTORATE

Child Justice Services Directorate aims at improving service delivery in child justice courts. The mandate of the Directorate is to ensure that the child justice system is fair and humane based on the principle of best interests and welfare of the child as enshrined in the Constitution and further provided for under the Child Care, Protection and Justice Act (CCPJA), Cap. 26:03 of the Laws of Malawi.

The Directorate is also a secretariat of the National Child Justice Forum (The Forum) which was established to ensure that a humane child justice system is available to the children in conflict with the law and those in need of care and protection. The Forum is chaired by Honourable Justice Fiona Mwale.

In 2021, the Directorate and the Forum with funding from UNICEF managed to train 70 magistrates nominated for designation as child justice magistrates at district and selected satellite courts as well as 35 court clerks on core competencies for child justice. As a result of the training, there has been marked improvement on adherence to procedure and matters of jurisdiction for child justice courts. Similarly, there has also been improvement in development, transmission and management of records within and beyond the Judiciary.

The Directorate and the Forum with funding from development partners managed to develop and publish a Compendium of Child Related Laws, Compendium of Laws for the Protection of Women and Children from Sexual and Gender Based Violence, National Standards for Child Justice Court Circuits, and the Child Justice Core Competencies Training Manual. These documents are being used as both reference and awareness materials.

As a way of ensuring that there is increased access to child justice and its related services to all without discrimination, the Directorate and the Forum facilitated the designation of child justice magistrates in remote and hard to reach areas. A total of 34 satellite courts were identified and covered under the initiative. The Directorate and the Forum have also implemented court circuits in these areas.

According to the Establishment Warrant, the Directorate is headed by a Director. However, the position is vacant. In the meantime, the duties of that Office are being performed by the Community Service Officer.

#### MALAWI JUDICIARY DEVELOPMENT PROGRAMME

The Malawi Judiciary Development Programme (MJDP) is the project management unit of the Judiciary and started its operations in 2003. The MJDP coordinates and facilitates the relationship between the Judiciary and development partners in the designing and implementation of activities funded by development partners.

In 2021, the major development partners were the European Union (EU) through the Chilungamo Programme, the United Nations Development Programme (UNDP) and the United Nations Office on Drugs and Crime (UNODC). Under Chilungamo Programme, the Judiciary trained judicial officers and members of staff. It also produced and published law reports and continued with the rehabilitation of Balaka, Rumphi and Likoma magistrate courts. UNODC assisted the Judiciary with funding to develop a manual on Asset Recovery and also to conduct training of trainers in Asset Recovery. UNDP is supporting the Judiciary in the development of a Case Statistics Tool for District Magistrate courts.

The breakdown of the funding is as follows:

- 1. European Union Chilungamo Programme committed K 214,091,387.65 for the implementation of the following activities:
  - » Meetings of the Criminal Justice Coordinating Committee
  - » Meetings of the Technical Committee of the Criminal Justice Coordinating Committee
  - » Review of Subordinate Court Rules
  - » Review of Plea Bargaining Rules
  - » Printing and publication of Law Reports (Years of Law Reports)
  - » Conducting Mobile Courts for the Magistrate Courts and the Child Justice Court
  - » Hearing of cases through Camp Courts
  - » Rehabilitation of Magistrate Courts in Balaka, Rumphi and Likoma.
  - » Review of Supreme Court of Appeal Act
  - » Development of Service Charter for the Judiciary
- 2. United Nations Development Programme through the National Statistics Office provided funds towards the development of a Case Statistics Tool for District Magistrate Courts.

#### INFRASTRUCTURE DEVELOPMENT

The Judiciary has physical court infrastructure country wide. The court infrastructure is not adequate to meet the demand for office and court accommodation of the Judiciary. Most of it is in dilapidated state. As a result, some court centres are accommodated in rented premises, while others are operating from dilapidated premises and others have been rendered non-functional. This has negatively affected the efficient and effective delivery of services to the public. Using the existing Infrastructure Development Plan, the Judiciary continued with the rehabilitation and construction of suitable court infrastructure.

Infrastructure development is implemented through funding from Government of Malawi under Public Sector Infrastructure Programme (PSIP) and European Union (EU) - Chilungamo Programme.

Infrastructure development falls under Estates Management Section which is headed by the Chief Maintenance Officer.

#### 1. BOLERO MAGISTRATE COURT

The court building is situated at a water-logged area and is hardly accessed during rainy season due to stagnant water around the building. ## The Judicial Complex Project

The Project has four components, namely, the Judiciary Headquarters Complex at City Centre opposite Parliament Building; the official residence of the Chief Justice in Area 10; the Warehouse for the Office of the Sheriff in Area 50, Kanengo; and the Judiciary Training Institute proposed to be located in Mponela. The component on the Judiciary Training Institute is not included in the preliminary procurement processes for consultants to design and supervise construction as it was added later following a meeting with the Right Honourable the Vice President where the Judiciary was presenting a progress report on Public Reforms. It was at that meeting that a decision was made to incorporate the Judicial Training Institute into the Judicial Complex Project. It is planned that the Judiciary Headquarters Complex will house the Supreme Court; the Court of Appeal; the High Court (all Divisions); and the Administration Block. The project is estimated to cost K120 billion.

The activities that have so far been undertaken include: stakeholder consultations; erection of signposts bearing the words "The Judiciary: Proposed Site for the Judiciary Headquarters"; production of the revised Environmental and Social Impact Assessment (ESIA); Cadastral and topographical surveys of the sites of the Judiciary Headquarters Complex, Official residence of the Chief Justice and the Warehouse for the Office of the Sheriff; and commencement of the procurement of services of consultants to design and supervise construction works.



## **Commercial Court Construction Project**

The Judiciary is constructing a court house for the Commercial Court in Blantyre with funding from the Government of Malawi. The project commenced in August, 2010 and was expected to be completed by August, 2012. Due to various challenges, the project has dragged and is currently at 95% completion.

#### THE OTHER SIDE OF JUDICIARY

#### CHILUNGAMO SACCO

## PARTICIPATION IN SOCIAL ACTIVITIES

Apart from routine office work, both judicial officers and members of staff of Judiciary participate in various activities including sports, evangelism, farming and music.

This edition of the Annual Report, highlights the story of *Jane Chimaliro*, a renowned netball player for the Malawi National Netball Team (The Queens) who is employed as a court clerk in the Judiciary.

Jane Chimaliro is a lastborn daughter in a family of four, two boys and two girls. She did her education at Chibavi Community Day Secondary School in the city of Mzuzu before joining the Judiciary in March, 2009.

She started playing serious netball when she was in secondary school. Her professional netball career started at ADMARC Sisters in Mzuzu before she joined Civonets Netball Club in 2007 where she is to this day. For her, the most memorable moments are when she was called to join the Queens in 2011 and when the Queens beat New Zealand in 2018. Then, New Zealand was ranked as the number one netball team in the world.

In her career as a member of the Queens, she has travelled far and wide with the team to countries such as New Zealand, Australia, Fiji, England, South Africa, Botswana, Namibia, Ethiopia, Uganda, Zimbabwe, Zambia, Tanzania and Lesotho.

She was voted as the best shooter at the African Netball Championship tournament which was hosted by Namibia in November, 2021.

#### **CHALLENGES**

Despite the positive strides made in the year 2021, the Judiciary faced various challenges. The major ones included:

- a. Covid-19 which forced the Judiciary to close courts as a precautionary measure against the spread and impact of the pandemic. This resulted in failure by the public to access court services, increase in the backlog of cases, and increase in the number of warrants pending execution.
- b. Inadequate funding the funding allocated to the Judiciary is inadequate to cater for both operations and implementation of activities. This continues to negatively affect the operations of the Judiciary.
- c. Integrated Financial Management Information System (IFMIS) In the year under review, the introduction of the new IFMIS negatively affected the operations and implementation of some activities of the Judiciary. Most payments could not be processed in time while others were not processed at all.
- d. Shortage of staff even though the Judiciary has a new Establishment Warrant which creates both new and additional positions, the vacancy rate remains high because most of the positions have not been filled. As a result, service delivery has been compromised.
- e. Inadequate and dilapidated infrastructure apart from being inadequate, most of the court infrastructure is in a dilapidated state. As a result, some court centres are accommodated in rented premises, while others are operating from dilapidated premises and others have been rendered non-functional. This has negatively affected the efficient and effective delivery of services to the public.
- f. Capacity gaps even though the Judiciary has a training policy, lack of funds has constrained it to regularly facilitate training of judicial officers and members of staff. This has resulted in skills and knowledge gaps which have in turn negatively affected the delivery of services to the public.
- g. Lack of motor vehicles the fleet the Judiciary has is both old and inadequate. As a result, some crucial operations and services such as court inspections and court circuits are not adequately carried out, thereby, negatively affecting both access to justice and the administration of justice.
