

His Lordship Honourable Chief Justice Rizine R. Mzikamanda, SC

It is once again with great pleasure that I present the Malawi Judiciary 2022 Annual Report. In the year 2022 the Judiciary continued to build on the achievements that been made in the preceding years. The Report therefore outlines the activities undertaken and challenges encountered in 2022. To begin with it pleased His Excellency the State President Dr. Lazarus McCarthy Chakwera to appoint four new Justices of Appeal and eleven new High Court Judges. The appointments increased the number of Supreme Court of Appeal Justices from seven to eleven and from thirty to forty-one High Court Judges. The appointments contributed to increased number of cases heard and concluded by the Judiciary.

Again the year 2023 saw the creation of a new Divi-

sion of the High Court namely, Financial and Economic Crimes Division. The Division will be solely responsible for hearing of cases relating financial crimes. It is my conviction that given requisite resources this Division will significantly contribute to the speedy resolution of cases relating to corruption brought before the Judiciary.

In the year under review the Judiciary in addition to local and international training conducted for judicial officers and members of staff sent representation to a number of conferences and as well hosted a conference. I deliberately engaged the Judiciary on these networking initiatives so that from interaction with other jurisdictions the Malawi Judiciary could broaden its jurisprudence and competencies in judicial service delivery. It is my hope that this objective will in the long run manifest in tangible results.

I reported in the 2021 Malawi Judiciary Annual Report that court rehabilitation and construction works were on-going at a number of sites. I am happy to report that construction and rehabilitation works were concluded at Likoma and Balaka District Magistrate Courts in 2022. The two courts benefited from funding from the European Union's Chilungamo Programme. The courts now offer a conducive environment for the public to access justice.

I am resolute to seeing the Judiciary fully embrace technology in its operations. In that regard more Districts courts were connected to GWAN in 2022. In addition, with assistance from United Nations Development Programme the Judiciary developed Case

Management System for Magistrate Courts. The System will be piloted in the Districts of Nsanje, Machinga, Dowa, Ntchisi, Nkhata-Bay and Mzimba. The plan is to gradually roll the System to all District Magistrate Courts and link the System to the Supreme Court of Appeal and High Court Case Management System. The Case Management System will enable the Judiciary and court users track status of cases.

Lack of adequate resources including human, finance and physical infrastructure continued to impede effective and efficient delivery of service by the Judiciary. It is my sincere hope that with continued support from all stakeholders most of the challenges faced by the Judiciary will gradually be minimized if not completely eliminated.

Let me at this juncture extend my appreciation to all

our stakeholders and partners for the support rendered to the Judiciary in 2022 without which support the Judiciary could not have achieved some of the developments highlighted in the report. The Judiciary is not yet where it envisions itself to be. Therefore, the call for continued collaboration and support from the stakeholders stands. Together we can create a better Judiciary that is responsive to the needs of all court users.

I hope going through this Annual Report one may have an appreciation of the operations of the Judiciary in 2022. I wish everyone a pleasant reading of the Report.

Embedded within the confines of the judiciary's fabric, are members of staff that work hand in hand with Judicial officers in ensuring that provision of all the necessities for proper conduct of judicial business as well as welfare of the workforce are well managed. It is in this regard that the report also contains a corresponding list of senior members of staff of the Judiciary, as its absence would entail an incomplete picture of the institutions structure.

As it were, of vital interest and importance is the report's highlights of the achievements and challenges experienced in the course of the year. Notable on the achievements are the case statistics from across the tiers of the courts. As the Judiciary symbolizes the epitome of the rule of law and good governance, these statistics speak as to how much the Judiciary has worked to sustain the rule of law, which is its Constitutional obligation. Additionally, the report goes beyond the statistics to focus on selected judgments, which have shaped the jurisprudence of this country.

In a bid to guarantee proper coordination in ensuring that set objectives are effectively achieved within set periods, the judiciary has also set up committees with an all-encompassing composition based on competences and abilities from within the institution. The same has been included in this report.

It is believed that this annual report will not only be a useful resource in affording the Judiciary an opportunity for reflection on its policy and strategic direction but also provide a base to various stakeholders who may be interested in the work of the Judiciary.

COMPOSITION, POWERS AND MANDATE OF THE MALAWI JUDICIARY

The Judiciary is one of the three branches of Government. The two other branches are the Executive and the Legislature, also known as Parliament. The separate status, function and duty of the Judiciary are expressed in section 9 of the Constitution where the Judiciary has been entrusted with the responsibility of interpreting, protecting and enforcing the Constitution and all laws in accordance with the Constitution in an independent and impartial manner with regard only to legally relevant facts and the prescriptions of law.

Chapter IX of the Constitution establishes courts at various levels, and outlines the composition and powers of each court. The Supreme Court of Appeal Act provides for the structure and powers of the Supreme Court of Appeal while the Courts Act provides for the powers and functions of the High Court and subordinate courts. In addition, the Labour Relations Act provides for the composition, powers and functions of the Industrial Relations Court.

The Supreme Court of Appeal


The Supreme Court of Appeal is the superior court of record, established under section 104 of the Constitution. Its jurisdiction and powers are conferred on it by the Constitution or any other law. It is the highest appellate court which hears appeals from the High Court and tribunals as an Act of Parliament may prescribe. As such, no court can be established of superior or concurrent jurisdiction with the Supreme Court of Appeal.

The Justices of the Supreme Court of Appeal comprise the Chief Justice and such number of other Justices not being less than three as may be prescribed by an Act of Parliament. The Chief Justice is appointed by the President and confirmed by the National Assembly by a majority of two thirds of members present and voting. Justices of Appeal are appointed by the President on the recommendation of the Judicial Service Commission. A Judge of the High Court may be appointed by the President on recommendation of the Judicial Service Commission to serve as an Acting Justice of Appeal where, for example, there are less than three serving Justices of Appeal. The Supreme Court of Appeal Act further provides for the jurisdiction and the constitution of the court when dealing with a particular matter.

High Court

The High Court is established under section 108 of the Constitution. It has unlimited original jurisdiction to hear and determine any civil or criminal proceedings under any law which includes reviewing any law and any action and decision of the Government for conformity with the Constitution. The Courts Act provides for its structure and additional powers. Apart from the Supreme Court of Appeal, there cannot be established a court of superior or concurrent jurisdiction with the High Court.

Besides the Principal Registry based in Blantyre, the Chief Justice, in exercise of his powers under section 7A of the Courts Act, established three district registries of the High Court. These are Lilongwe District Registry, Mzuzu District Registry and Zomba District Registry. In an effort to enhance access to justice and improve service delivery, there has also been established six specialized divisions of the High Court. The divisions include Civil Division, Commercial Division, Criminal Division, Family and Probate Division, Revenue Division and Financial Crimes Division. The Act creating the Financial Crimes Division was assented to by the President on 12th November, 2022.

Judges of the High Court are appointed by the President on the recommendation of the Judicial Service Commission. In 2022, the President appointed eleven judges of the High Court.

Subordinate Courts

Subordinate courts are established under section 110 of the Constitution and are below the High Court. These courts are: the Industrial Relations Court presided over by the Chairperson or Deputy Chairperson with original jurisdiction over labour disputes and such other issues relating to employment under the Labour Relations Act; subordinate courts under the Courts Acts and the Child Care, Protection and Justice Act which are presided over by magistrates; and Local Courts with the jurisdiction limited exclusively to civil cases at customary law and such minor common law and statutory offences as prescribed by the Local Courts Act which are presided over by lay persons.



Honourable Chief Justice Rizine Robert Mzikamanda, SC Chief Justice of the Republic of Malawi




The State President appointed Honourable Justice Rizine R. Mzikamanda, SC as the Chief Justice on 7th January 2022 and Parliament confirmed his appointment on 14th March 2022 and was sworn in on 9th April 2022.

He was born on 30th November, 1958. He is married and has six children. He holds a Bachelor of Laws (Hons) from the University of Malawi (1983) and a Master of Laws from Hull University, England (1992).

He started his career in the Judiciary in 1983 as a Resident Magistrate and rose to the ranks of Principal Resident Magistrate and Chief Resident Magistrate before he was appointed Deputy Registrar and later Senior Deputy Registrar of the High Court and Supreme Court of Appeal. He was appointed Judge of the High Court in 1997 and Justice of Appeal in 2012.



Honourable Lord Justice Lovemore Paul Chikopa, SC



The Honourable Justice Lovemore P. Chikopa, SC was born on 9th August, 1965. He is married and has children. He holds a Bachelor of Laws (Hons) from the University of Malawi (1987) and a Master of Business Administration degree from the University of Zambia (2021).

He started his career in the Ministry of Justice as State Advocate. He then worked in the private sector with Small Enterprises Development of Malawi (SEDOM) and in private legal practice before joining the Office of the Ombudsman as Principal Investigations Officer/Acting Chief Legal Officer.

He joined the Judiciary in 1998 as Principal Resident Magistrate where he rose to the rank of Chief Resident Magistrate. He was appointed Judge of the High Court in 2000 and Justice of Appeal in 2012.

Honourable Lord Justice Healey Stuart Burrows Potani



Honourable Lord Justice Sylvester Augustino Kalembera





Honourable Lord Justice Dingiswayo Madise



Honourable Lady Justice Dorothy nyaKaunda Kamanga



Honourable Lady Justice Fiona Atupele Mwale



OFFICE OF THE REGISTRAR

The Office of the Registrar of the High Court and Supreme Court of Appeal (the Registrar) is established under section 7 of the Courts Act. Under the Constitution, the power to appoint a Registrar is given to the Chief Justice on the recommendation of the Judicial Service Commission.

The Registrar is the Controlling Officer for the Judiciary and bears the responsibilities as provided for under the Public Finance Management Act and the Public Service Act. The office is responsible for the day to day running of the Judiciary at all levels including handling of complaints, and public relations. The Registrar reports directly to the Chief Justice.

The Registrar is accountable to Parliament on all issues related to the usage of financial resources appropriated to the Judiciary.

The office of the Registrar is also responsible for case management in the High Court and Supreme Court of Appeal. This entails registration, allocation of resources and, in consultation with Judges, allocation of dates of hearing of cases. Additionally, the Registrar performs judicial functions.

The Registrar is assisted by the Senior Deputy Registrar, the Deputy Registrar and Assistant Registrars. Under the new Establishment of the Judiciary, the office of the Registrar has been renamed as Chief Registrar, with Deputy Chief Registrars to be placed at the Supreme Court and the yet to be established Court of Appeal. There shall be a Registrar (assisted by Assistant Registrars) responsible for each of the High Court Divisions and Registries.

SUBORDINATE COURTS

INDUSTRIAL RELATIONS COURT

The management of the Industrial Relations Court (IRC) is the responsibility of the Chairperson. In the performance of the administrative functions and duties, the Chairperson acts in accordance with policies of the Judiciary and reports to the Registrar of the High Court and Supreme Court of Appeal. The Chairperson is based at the Principal Registry in Blantyre and is assisted by Deputy Chairpersons and Assistant Registrars positioned in the registries of the Court.

In the period under review, the IRC had four registries. The Principal Registry in Blantyre, Lilongwe Registry, Mzuzu Registry and Zomba Registry. This means that under the new Establishment, there are two registries which are yet to be operationalized. These are Kasungu Registry and Luchenza Registry.

COURTS OF MAGISTRATES

The courts of magistrates are presided over by professional (trained as lawyers) and lay magistrates. The majority of cases in Malawi are handled by the magistrates.

There are four judicial administrative regions, each headed by a Chief Resident Magistrate, namely South, Centre, North and East. Under the new Establishment, there are two additional judicial regions, which are South East (Luchenza) and Central East (Kasungu). Below the Chief Resident Magistrate is the office of Principal Resident Magistrate, Senior Resident Magistrate, and lay magistrates who are graded as follows: First Grade; Second Grade; and Third Grade Magistrates.

PRECEDENTS

Summaries of some of the judgments of the Supreme Court of Appeal and the High Court delivered in 2021

Registered Trustees of Medical Society of Malawi v Makandia t/a Oracare Dental Clinic

SUPREME COURT OF APPEAL

(Being High Court, Zomba District Registry, Personal Injury Case No. 645/2013)

Date of Judgment: 26 April 2022 MSCA Civil Appeal No. 58/2017

Summary

The appellant was a long-established health insurance service provider and the respondent was a professional dentist of years of experience with dental clinics in some major cities in the country. Since as far back as 1991, the appellant and the respondent engaged in contractual agreements where the respondent provided dental services to the appellant's members for which the appellant would periodically pay the respondent upon the respondent submitting to the appellant relevant invoices. On several occasions the agreements were terminated on account of misunderstandings between the parties but subsequently re-entered. In 2010, the appellant terminated the agreement again with effect from the date of the letter, citing as reasons, unsustainable claiming pattern by the respondent. It is this termination and events around it that resulted into the respondent suing – seeking damages for defamation and embarrassment, on account of the negative publicity of the termination of the agreement by the appellant. He also sought damages for loss of business. The appellant admitted liability and pursuant to that, damages in respect of defamation and embarrassment were settled. The matter then proceeded before the Assistant Registrar for assessment of damages for loss of business. The Assistant Registrar awarded the respondent K1,519,916,200.65. The appellant considered the award excessively and unreasonably high, hence the appeal. Held – Allowing the appeal and reducing the assessment of loss of business payable by the appellant to K4 200 000.00.

- (1) That damages for loss of business are multi-dimensional. They could be general damages, for example, where the claimant asserts that as a result of the defendant's conduct, his business reputation and good will has been tarnished. The actual consequences of loss of business reputation and loss of good will on the business will invariably not be easy to determine and would much depend on the nature of the business and the extent to which the impugned actions will have affected the business.
- (2) That loss of business profits are quantifiable losses which must be in the knowledge of the claimant and therefore should not be kept away from the defendant as well as the court. These are what are referred to as special damages.
- (3) That where a clear and precise amount of a particular item which is being claimed has crystallized or it can be measured with complete accuracy in monetary terms, the plaintiff must plead this loss as special damages in order to warn the other party. Moreover, it is cardinal that the actual quantum sought must also be specified with particularity since it is already available to the plaintiff.
- (4) That general damages will, by their nature be generally pleaded and where proven, generally awarded at the discretion of the court. Special damages, on the other hand, must be specifically pleaded and where proven

they will be specifically awarded.

- (5) That when a matter is referred for damages to be assessed, the assessment must follow the path of and be within what has been claimed in the pleadings. An assessment of damages could never be without context. In other words, what was to be assessed and probably payable, if so found, as loss of business was to be within what had been claimed in the pleadings.
- (6) That where an agreement between parties has been reduced to writing and the document containing the agreement has been signed by one or both of them, the party signing will ordinarily be bound by the terms of the written agreement.
- (7) That there was nothing in the respondent's pleadings to direct the court to any special damage or damages beyond what was provided for in the contract agreement between the parties. It was therefore to that extent only that the appellant was liable to the respondent for loss of business for termination of the agreement.

Chapinga t/a Matechanga Motel & Enterprises v National Bank of Malawi Ltd SUPREME COURT OF APPEAL

(Being High Court, Principal Registry Commercial Division, Commercial Case No. 314/2016)

Date of Judgment: 26 April 2022 MSCA Civil Appeal No. 29/2018

Summary

The respondent took out a third-party notice against the appellant dated April 21, 2017. It wanted the appellant to indemnify it in respect of damages, in the sum of K24 500 000.00, awarded to one Mr. Osman for loss of use of the motor vehicle. This claim was allegedly pursuant to some agreement entered into between the parties hereto in relation to the redemption of the motor vehicle. The third-party notice was after a few hiccups and mutual accommodations set down for hearing on February 6, 2018. The notice of hearing in respect thereof was dated November 17, 2018 and was served on the appellant on November 18, 2018. On February 1, 2018 the appellant's lawyers were served with a notice from the respondent indicating its intention to cross-examine the appellant. On February 5, 2018 the appellant's lawyers wrote the court below informing it and the respondent that they would not be available on the 6th as they would be attending to another matter before the Commercial Court in Lilongwe.

On 6 February, another counsel appeared on behalf of the appellant and sought an adjournment of which the respondent opposed on the basis that the appellant and her counsel were abusing the court process - seeking needless adjournments for no sound reason or at all. The court below dismissed the application for an adjournment and proceeded to enter judgment against the third party in the sum of K24 500 000.00 being the indemnity sought by the respondent in respect of the damages awarded to Mr. Osman.

The appellant was dissatisfied with the decision and appealed to the Supreme Court of Appeal which considered whether the court below properly and correctly exercised its discretion when it refused to adjourn the matter before it on February 6, 2018, whether the judgment was entered in error as alleged or at all, and whether on the evidence before it the court below came to the correct decision.



Held – Setting aside the judgment in that it was made in disregard of due process:

- (1) That parties are entitled to apply for an adjournment. They however have no right to the adjournment itself. Whether or not an adjournment will be granted is in the discretion of the court before whom the application for one is made. And such court will only favourably exercise its discretion to grant an adjournment for good cause.
- (2) That the court below erred in entering the judgment. The business of the court on that day was to first hear an application for an adjournment. Upon its dismissal the Court below should have, in the court's view, then proceeded to deal with the Third Party Notice by way of hearing and thereafter rendering its decision. It did not do so.

Muluzi V Attorney General SUPREME COURT OF APPEAL

(Being Constitutional Case No. 1 of 2011)

Date of Judgment: 17 May 2022 MSCA Constitutional Appeal No. 25/2018

Summary

In 2009 the Appellant was charged in the High Court with 15 counts of corruption, fraud and theft by public servant under the Corrupt Practices Act and the Penal Code. In the course of the trial, the appellant sought to challenge the constitutionality of section 32 (2) (b) and (c) of the Corrupt Practices Act. The court below determined that the challenge raised a constitutional question and directed the appellant to seek certification from the Chief Justice that the matter be determined as such. The appellant sought and obtained certification to file Originating Summons to resolve the constitutional question. After a full hearing, the High Court, sitting in a constitutional matter, dismissed the appellant's suit, finding section 32(2)(b) and (c) of the Corrupt Practices Act constitutional and declaring that it did not infringe the right to a fair trial or the right to remain silent under section 42 of the Constitution. The court below also found that the provision did not require an accused to disprove an essential element of the offence created. It further declared that the provision was a reasonable limitation of the presumption of innocence and that it imposed an evidential as contrasted with a legal burden on an accused to rebut the reverse burden of proof on balance of probabilities. The appeal derives from that determination.

Held – Declining the appeal and upholding the decision of the lower court and ordering that section 32(2)(b) and (c) of the Corrupt practices Act is not unconstitutional:

- (1) That the matter was brought to the Chief Justice for certification using a wrong procedure and the Chief Justice proceeded to certify it. There was an error on how this constitutional matter came to be, the proper procedure was not followed. However, the Chief Justice having certified the matter as Having been complied with section 9 (2) of the Courts Act, and the Constitutional panel having substantially heard and determined the originating motion, the court could not undo both of these parallel processes. Hence, the court reluctantly proceeded and determined the appeal on its merits.
- (2) That section 32 (b) and (c) of the Corrupt Practices Act must have been enacted pursuant to the fundamental principles of the Constitution and must be understood purposively because it is undeniably linked to the Constitution.
- (3) That section 32(b) and (c) of the Corrupt Practices Act does not take away the duty of the State or the

burden on the prosecution to prove its case against an accused beyond reasonable Doubt. In any event, under both section 32 (2) (b) and (c) the State has to respectively establish prima facie that the accused is 'in control or possession of pecuniary resources or property disproportionate to his present or past official emoluments or other known sources of income;' or 'in receipt directly or indirectly of the benefit of any services which he may reasonably be suspected of having received corruptly or in circumstances which amount to an offence under the Corrupt Practices Act'.

- (4) That section 32 (2) (b) and (c) Of the Corrupt Practices Act does not create a reverse onus provision in respect of legal burden of proof but merely affords an accused a possible defence against conviction after the prosecution establishes the existence of certain facts and circumstances which without a defence being mounted, would still be required to scale the burden of proof beyond reasonable doubt if a conviction is to be secured.
- (5) That where the investigation by the Anti-Corruption Bureau leads to a conclusion that a public officer under investigation does disclose the circumstances envisaged in section 32(1)(a) through (c) of the Corrupt Practices Act, such public officer may then be charged with the Offence of "having or having had under his control or in his possession pecuniary resources or property reasonably suspected of having been corruptly acquired" under section 32 (2) (c) of the Said Corrupt Practices Act.
- (6) That the first part of section 32 (2) (b) and (c) of the Corrupt Practices Act Creates an offence that is complete in itself without any need for an accused person to prove his Innocence.
- (7) That where the prosecution Provides sufficient evidence to establish a prima facie case that an accused has or has had under his control or in his possession pecuniary resources or property reasonably suspected of having been corruptly acquired, a court will call upon an accused to enter a defence.
- (8) That the second part of section 32 (2) (c) of the said Corrupt Practices Act then merely allows an accused person to provide evidence that circumstances exist by which he was able to "maintain such a standard of living, or how such pecuniary resources or property came under his control or his possession, or how he came to enjoy the benefits of such services," and nothing more.
- (9) That what the second part of section 32 (2) (c) of the Corrupt Practices Act does is to provide a possible defence to the accused. On being made aware of such possible defence the Prosecution can then negative such a defence.



COURT SERVICES AND GENERAL ADMINISTRATION

Court administration involves the performance of many functions including human resource management, fiscal and financial management, case flow management, information and technology management, jury management, infrastructural or estate development, public relations, intergovernmental liaison, security, procurement, court reporting, court interpretation and advisory services. Some of the managerial functions overlap with judicial functions. This is also reflected in the Judicature Administration Act, Cap. 3:10 of the Laws of Malawi ("the Act") which vests such responsibility in the offices of the Registrar of the High Court and the Supreme Court of Appeal, and the Chief Courts Administrator.

The Chief Courts Administrator is the most senior member of staff of the Judiciary. Under the Act, he or she is responsible for overseeing the general administration (including security, procurement, information and technology management, infrastructural development, financial and fiscal management, and human resource management) of the Judiciary.

According to section 3 of the Act, the Chief Courts Administrator is subordinate to the Registrar but in the discharge of functions and duties, he or she is subject to the direction of the Chief Justice. The Act also governs the terms and conditions of service for members of staff of the Judiciary who, under the Act, are all non-judicial officers.

INFORMATION COMMUNICATION AND TECHNOLOGY DIVISION

The Division is responsible for the development, management and maintenance of Information and Communication Technology (ICT) infrastructure in the Judiciary. This includes offering support to users of ICT, development and implementation of computer systems, computer network and hardware management.

According to the Establishment Warrant, the Division is headed by the Director of ICT. However, the position is vacant. In the meantime, the duties of that office are being performed by the Chief Systems Analyst.

In the year 2022 the Division successfully implemented the following:

- a. Facilitated the installation of Government Wide Area Network (GWAN) at High Court Principal Registry, High Court Commercial Division Blantyre, and district court centres of Balaka and Likoma;

OFFICE OF THE SHERIFF OF MALAWI

The Office of the Sheriff of Malawi is created under the Sheriffs' Act, Cap. 3:05 of the Laws of Malawi ("the Act"). It has the responsibility of enforcing judgments and orders of all courts. Enforcement is the last stage of the judicial process after the legal rights of the parties have been determined in a judgment or an order.

During this process, a judgment or an order of the court is made effective in order to enable the successful party reap the fruits of his judgment. Conversely, where there is voluntary compliance with the judgment or order of the court by the losing party, enforcement by sheriffs becomes unnecessary.

The Act empowers the President to appoint a person as Sheriff of Malawi. In the absence of such appointment, the Registrar of the High Court serves as the Sheriff of Malawi. In practice, the day-to-day administration and management of that Office is done by the Office of the Deputy Sheriff which position is vacant. In the meantime, the duties of that Office are being performed by the Principal Assistant Sheriff.

CHILD JUSTICE SERVICES DIRECTORATE

Child Justice Services Directorate aims at improving service delivery in child justice courts. The mandate of the Directorate is to ensure that the child justice system is fair and humane based on the principle of best interests and welfare of the child as enshrined in the Constitution and further provided for under the Child Care, Protection and Justice Act (CCPJA), Cap. 26:03 of the Laws of Malawi.

The Directorate is also a secretariat of the National Child Justice Forum (the Forum) which was established to ensure that a humane child justice system is available to the children in conflict with the law and those in need of care and protection. The Forum is chaired by Honourable Justice Fiona Mwale.

In the year 2022 the Directorate carried out the following activities:

- a. With funding from United Nations Children's Fund (UNICEF), the Directorate facilitated training of 50 court clerks from across the country in core child justice competencies and data compilation, processing and transmission.
- b. Distributed reference materials published by the Child Justice Directorate through the National Child Justice Forum.

MALAWI JUDICIARY DEVELOPMENT PROGRAMME

The Malawi Judiciary Development Programme (MJDP) is the project management unit of the Judiciary and started its operations in 2003. The MJDP coordinates and facilitates the relationship between the Judiciary and development partners in the design and implementation of activities funded by development partners.

In 2022 the major development partners were the European Union (EU) through the Chilungamo Programme, the United Nations Office on Drugs and Crime (UNODC), and the United Nations Development Programme (UNDP).

- 1. Under the Chilungamo Programme, the European Union committed MK 214,091,387.65 for the implementation of the below outlined activities:
- a. Training of 87 Judicial Officers on Laws protecting vulnerable groups.
- b. Publishing of 1000 copies for 2015-2018 Malawi Law Reports.
- c. Meetings of Criminal Justice Coordinating Committee and Technical Committee to the Criminal Justice Coordinating Committee.
- d. Reviewing and validating the Subordinate Court Rules.
- e. Reviewing of the Plea Bargaining Rules.
- f. Conducting Mobile Courts for the Magistrate Courts and Child Justice Courts.
- g. Hearing of cases through Camp Courts.
- h. Rehabilitation of Balaka, Rumphi and Likoma Magistrate Courts.
- i. Procurement of ICT Equipment and furniture for Balaka, Rumphi, Likoma and Dowa Magistrate Courts.
- j. Review of the Supreme Court of Appeal Act.
- 2. The United Nations Office on Drugs and Crime (UNODC) assisted the Judiciary with funding for:
- a. Training of trainers on Asset Recovery.
- b. Development of the Asset Recovery Handbook for the Judiciary.
- 3. The United Nations Development Programme through the National Statistics Office supported the Judiciary to:
- a. Development and deployment of a Case Management System (CMS) for Courts of Magistrates.
- b. Training of Magistrates and Clerks from the Spotlight Initiative Programme districts on the use of the Case Management System.

ESTATE DEVELOPMENT

The Judiciary has physical court infrastructure country wide. The court infrastructure is not adequate to meet the demand for office and court accommodation of the Judiciary. Most of it is in dilapidated state. As a result, some court centres are accommodated in rented premises, while others are operating from dilapidated premises and others have been rendered non-functional. This has and continues to negatively affect the efficient and effective delivery of services to the public. Using the existing Infrastructure Development Plan, the Judiciary continued with the rehabilitation and construction of suitable court infrastructure.

Infrastructure development is implemented through funding from Government of Malawi under Public Sector Infrastructure Programme (PSIP) and European Union (EU)-Chilungamo Programme.

Infrastructure development falls under Estates Management Section which is headed by the Chief Maintenance Officer.

The Judicial Complex Project

The Project has four components, namely, the Judiciary Headquarters Complex at City Centre opposite Parliament Building; the official residence of the Chief Justice in Area 10; the Warehouse for the Office of the Sheriff in Area 50, Kanengo; and the Judiciary Training Institute proposed to be located in Mponela.

The Judiciary has procured the services of MOD/Norman Dawban Consultants to design and supervise construction works. The consultants have since submitted an Inception Report and sketch scheme designs. It is expected that the final designs will be ready in 2023 and actual construction to commence in the middle of that year. In relation to the Judiciary Training Institute, the Department of Surveys conducted field cognisance survey to determine the extent of the area of land on which the Judiciary Training Institute shall be constructed.

Commercial Court Construction Project

Discussions are ongoing between the Government side comprising the Judiciary, Ministry of Transport and Public Works, Ministry of Finance, Ministry of Economic Planning and Development, and the Contractor for the project to agree on modalities to finalize the project.

Bolero Magistrate Court

The construction works commenced on 5th August, 2021 and were expected to be completed by 15th April, 2022. Due to a number of reasons the project has stalled.



Chipoka Magistrate Court

The construction works commenced on 15th November, 2021 and were expected to be completed by 15th May, 2022. Due to a number of reasons the project has stalled.

Balaka Magistrate Court

The rehabilitation works commenced in 2019, despite the numerous challenges works were completed on 28th September, 2022.

Rumphi Magistrate Court

The rehabilitation works commenced in 2020. It is expected that construction works will be completed in the first quarter of 2023.

Likoma Magistrate Court

The construction works commenced in July 2021 and were completed in September, 2022.

Official Residence for the Chief Justice in Blantyre

The building dates back to the colonial era. Most of its fittings are outdated and in serious need of repair and maintenance.

Following all necessary procurement process a contractor was identified to carry out the rehabilitation works. Rehabilitation works are expected to start in the first quarter of 2023.

The Supreme Court of Appeal Building in Blantyre

The building housing the Supreme Court of Appeal in Blantyre was last rehabilitated in 2008. Over the years the building has developed serious leaks and has generally deteriorated. The process of procuring services of a contractor to rehabilitate the building is in progress and works are expected to commence in January, 2023.

Entrance Road to Chichiri Court Premises in Blantyre

The road leading into Chichiri court premises had numerous potholes that necessitated rehabilitation. Part of the road has since been rehabilitated, the remaining part will be rehabilitated in the 2023/24 Financial Year.

NETWORKING AND INTERNATIONAL COOPERATION

The Judiciary continued to engage in several networking activities that contributed towards capacity development, sharing of information and increasing partnerships with different local and international institutions. In the year under review, the following were the different networking activities that were undertaken.

1. Southern Africa Chief Justices Forum (SACJF) Judicial Symposium on Digitization and Internet Governance

Chief Justice Rizine Mzikamanda, SC was among the 12 Southern African Chief Justices who attended the Symposium on Digitization and Internet Governance held in Nairobi, Kenya from 21st to 22nd April 2022.

The forum gave an ideal opportunity for the Chief Justices and other distinguished Jurists from across the region to share experiences, ideas and perspectives on the administration of justice and the question of Digitisation and Internet Governance.

The symposium was jointly organized by SACJF and the International Commission of Jurists (ICJ) under the theme Digital Transformation of Judiciaries in Africa and Experiences in the face of the COVID-19 Pandemic in their jurisdictions.



2. Election Dispute Resolution (EDR) Symposium for Supreme Court Judges

Justice Frank Kapanda, SC represented the Supreme Court of Appeal in a 3-day Election Dispute Resolution (EDR) symposium for Supreme Court Judges of Kenya which was held from 6th to 10th June 2022. The symposium was organized to firm up the preparedness of the Judiciary of Kenya to handle election petitions ahead of the August 9, 2022, General Election.

CHALLENGES

Despite the positive strides made in the year 2022, the Judiciary faced various challenges. The major ones included:

- a. Inadequate funding the funding allocated to the Judiciary is inadequate to cater for both operations and implementation of activities. This continues to negatively affect the operations of the Judiciary.
- b. Shortage of staff even though the Judiciary has a new Establishment Warrant which creates both new and additional positions, the vacancy rate remains high because most of the positions have not been filled. As a result, service delivery has been compromised.
- c. Inadequate and dilapidated infrastructure—apart from being inadequate, most of the court infrastructure is in a dilapidated state. As a result, some court centres are accommodated in rented premises, while others are operating from dilapidated premises and others have been rendered non-functional. This has negatively affected the efficient and effective delivery of services to the public.
- d. Capacity gaps even though the Judiciary has a training policy, lack of funds has constrained it to regularly facilitate training of judicial officers and members of staff. This has resulted in skills and knowledge gaps which have in turn negatively affected the delivery of services to the public.
- e. Shortage of motor vehicles –the fleet the Judiciary has, is both old and inadequate. As a result, some crucial operations and services such as court inspections and court circuits are not adequately carried out, thereby, negatively affecting both access to justice and the administration of justice.
- f. Inadequate and obsolete furniture and office equipment most courts do not have adequate and suitable furniture and other office equipment.
- g. Lack of proper storage facilities for court records and exhibits most court centres do not have enough space to store large volumes of court files and court exhibits.
